Expression of Interest for Occupation of Booth/Stall/Space at Central Flacq market/fair and Lallmatie Fair.

In accordance with Section 57 of the Local Government Act 2011, the District Council of Flacq hereby invites Expression of Interests from residents within the administrative area of this Council for the Occupation of Booth/Stall/Space at the above market/fair for a period of three years and will be renewed upon termination of the contract.

The Eligibility criteria are as follows:-

1. Applicant should be over 18 years.
2. Applicant should be a resident within the administrative area of the District Council of Flacq.
3. Applicant should be unemployed.
4. Applicant should not be holder of any stall shop or other place inside a market or fair or any place of business.
5. Applicant should undertake to occupy the stall personally.

The minimum amount to be quoted for each booth/stall/space should not be:

- (i) less than Rs20,000 for Poultry, Fish, Meat at Central Flacq Market/Fair and Lallmatie Fair
- (ii) less than Rs40,000 for fruits and vegetable at Central Flacq Market
- (iii) not less than Rs 50,000 for Auction space and Craft market at Central Flacq Market.

Please note an applicant selected to be allocated a stall in Fruit/Vegetable the Fixed Market at Central Flacq Market will also be allocated an additional stall for sale of fruits or vegetables in the Central Flacq Fair on Wednesdays and Sundays only against payment of the yearly fee amounting to Rs 8,400.
